SPECIAL TERMS AND CONDITIONS OF PARTICIPATION IN EVENTS ORGANISED BY ESTRADA POZNAŃSKA IN THE "SCENA NA PIĘTRZE" THEATRE

related to the prevention of COVID-19

ı

- 1. These terms and conditions (hereinafter referred to as the "Terms and Conditions") set out specific rules applying to the participation in events (hereafter the "Events") organised by the "Scena na Piętrze" Theatre (hereafter "Scena" Theatre).
- 2. The Terms and Conditions have been prepared as means of implementing the Guidelines for organisers of cultural and entertainment events during the SARS-CoV-2 epidemic in Poland issued by the Ministry of Culture and National Heritage, the Ministry of Development, and the Chief Sanitary Inspector, which are available online at:

Ш

- 1. The Terms and Conditions are provided to every person purchasing a ticket entitling the holder to participate in an Event (hereafter the "Ticket"), before such a purchase is made.
- 2. Purchasing a Ticket after reading the Terms and Conditions means that the buyer has accepted the Terms and Conditions, and commits to complying with their provisions.
- 3. The Terms and Conditions are binding on all persons intending to participate in the Event, regardless of whether they purchase the Ticket in person or through third parties.

Ш

- 1. Every participant of the Event is obliged to follow the rules of order which are in place on the "Scena" Theatre's premises, particularly with respect to the logistics and maintaining safety in the venue, and to comply with the guidelines of the "Scena" Theatre's staff.
- 2. The "Scena" Theatre's staff members are authorised to prevent any person who fails to comply with the Terms and Conditions, rules of order, or guidelines referred to in section 1 above, from participating in the Event. In such cases, the person concerned shall not be entitled to a refund of the price of the Ticket.

- 1. Participation in Events is restricted to persons who, to the best of their knowledge, are not infected with SARS-CoV-2, and are not in quarantine or under epidemiological supervision.
- 2. Before entering the "Scena" Theatre's premises, every participant of the Event is required to submit a written statement (hereinafter the "Statement") to the effect that, to the best of their knowledge, they are not infected with SARS-CoV-2, and are not in quarantine or under epidemiological supervision.
- 3. Any person failing to meet the requirements set out in section 1 and refusing to submit the Statement shall be obliged to refrain from participating in the Event, or shall be prevented from participating in the Event, in which case the price of the Ticket will not be refunded.
- 4. "Scena" Theatre provides a template for the Statement, which is available, for example, via the Estrada Poznańska website.

٧

- 1. "Scena" Theatre shall provide every person participating in the Event with a form (hereinafter the "Form") where the person may enter the data indicated in the Form.
- 2. Providing the data referred to in section 1 above is not obligatory, and its purpose is to create a possibility of contacting the person submitting their data in the case of risk of SARS-CoV-2 infection related to participation in the Event.
- 3. In the event of risk of SARS-CoV-2 infection related to participation in the Event, the data contained in the Form may be supplied by "Scena" Theatre to appropriate sanitary services.
- 4. Forms will be retained by "Scena" Theatre for 2 weeks after the date of the Event.

۷I

- 1. "Scena" Theatre may introduce a procedure for checking the body temperature of all persons entering the "Scena" Theatre's premises.
- 2. If a person refuses to undergo a body temperature check or is found to have elevated temperature, they will be refused participation in the Event, in which case the price of the Ticket will not be refunded.

VII

- 1. All persons staying on the "Scena" Theatre's premises are unconditionally obliged to cover the mouth and nose with clothing or its parts, a face shield, mask, visor or protective helmet. The obligation also applies to persons in the auditorium during the Event.
- 2. "Scena" Theatre does not provide viewers with face masks or visors.

- 3. All persons staying on the "Scena" Theatre's premises, entering the "Scena" Theatre's area or auditorium, taking seats and leaving the auditorium or the "Scena" Theatre's premises, are unconditionally obliged to comply with the rules of order and guidelines of staff members. A minimum distance of not less than 2 m from other people in the queue to enter or exit the premises, and not less than 1.5 m in all other cases, must be maintained.
- 4. Event participants may be required to disinfect their hands with a disinfectant which is provided by "Scena" Theatre in designated locations, especially when entering the "Scena" Theatre's premises or the auditorium, or leaving these areas.
- 5. The "Scena" Theatre's staff members are authorised to prevent any person failing comply with the rules referred to in preceding sections from participating in the Event. In such cases, the person concerned shall not be entitled to a refund of the price of the Ticket.

VIII

The procedure for admitting Event participants to the "Scena" Theatre's premises will commence 1 hour before the scheduled time of the Event.

IX

- 1. "Scena" Theatre shall cut available seating in the auditorium by at least 50 percent.
- 2. Event participants are obliged to comply with the "Scena" Theatre's rules of audience organisation.
- 3. Rows in the auditorium should be occupied alternately, with one seat left free between viewers.
- 4. Participants are prohibited from changing their designated seats.
- 5. The "Scena" Theatre's staff members are authorised to prevent any person failing comply with the rules referred to in preceding sections from participating in the Event. In such cases, the person concerned shall not be entitled to a refund of the price of the Ticket.

Χ

- 1. Event participants are requested to use electronic tickets whenever possible.
- 2. Viewers are requested to make all payments by non-cash means.

ΧI

- 1. The rules of participation in the Event or staying on the "Scena" Theatre's premises may be expanded or modified at any time.
- 2. The Terms and Conditions shall become effective on 14 August 2020, and shall remain in full force and effect until revoked.
